| Season Options | |

The 2011 troll salmon season is shaping up with a one third reduction in chinook opportunity compared to what we had in 2010. Our total troll opportunity for the spring and summer should be in the area of a 35,000 chinook quota for the area North of Cape Falcon. Our delegation to the Vancouver PFMC March meeting was particularly frustrated by NMFS refusal to reconsider the allowed ocean harvest rate that last year was determined to be reduced this year to at least 37% regardless of the strength of this year's Lower Columbia River (LCR) Tule run. This year the LCR Tule run is up considerably. More of the details will be available at the Port meetings. The South of Falcon troll season looks considerably better this year primarily due to a prediction of 729,000 chinook abundance forecast for 2011 chinook run from the Sacramento River System. The South of Falcon troll season is scheduled to start on April 15.

The coho hatchery forecast for 2011 is slightly reduced from 2010, but the wild component of the run is stronger in 2011. The allowed coho harvest will be small and mostly limited to marked select coho only, however, because of the strong wild coho component, we may have a late all coho opportunity this year in late August. Please see the attached options for more details.

Since last season there has been less pressure from WDFW and NMFS to move the chinook troll fishery into a marked select fishery that is similar to the marked select coho fishery. This year there are no chinook marked select troll fisheries proposed, but please keep track of the percentage of marked select chinook that you catch for future season reference

The WTA Board has evaluated the "genetic stock identification" program (GSI) and thinks the program might be a long term means to avoid ESA listed stocks. Scott Blankenship at WDFW has obtained a grant to continue the GSI program for the 2011 season. The grant provides funds to pay the fishermen \$5.50 for each sample taken. We will need salmon trollers working out of Westport, LaPush, and Neah Bay to help with the sample taking. Please contact Joe if you are willing to take samples for the Spring, Summer or both seasons. Again, big thanks to Jim Olson (Our PFMC rep) who led our crew of Joe Dazey, Steve Wilson, Dick Good, Kim Reisbick, Greg Mueller, Joel Kawahara and me at the March PFMC meeting. We are headed for San Mateo, CA the second week in April to finalize the 2011 season. Be sure and come to the port meetings or contact the Board Members directly to let your views known on how to best utilize the fish that we have available for 2011. We hope everyone can make it to a port meeting in your area. Also, if you are around Westport on March 28, at 7 PM, the PFMC will be taking comments on how to manage our fishery for 2011.



PFMC Report – Jim Olson

The first PFMC gave less fish than I had expected. The exploitation rate on lower river hatchery is set on 37%. This is down from 38% last year. We are currently looking at a troll quota of 35,000 to 40,000. We are still waiting for numbers to come from Canada and Alaska. We need to craft a season that best uses the fish that we have.

We will be doing the two North of Falcon meetings March 15 in Olympia and April 5th in Lynnwood. It helps to have a good showing of

trollers at these meetings.

Come to the port meetings and tell your board members what you would like to see in a season. The port meetings and board meetings are open to all members.

I would like to thank all the trollers that came to Vancouver WA for the PFMC meeting. Your input makes my job easier.

PFMC Habitat Committee – Joel Kawahara


The Habitat Committee reviewed the Sacramento Fall Chinook Overfishing Assessment produced by the STT. HC added the existing EFH recommendations from the OCAP BIOP for Sacramento Fall Chinook. The Council added these recommendations to the Overfishing Assessment. The Council also proactively applied the Amendment 16 criteria for overfished stocks to the SRFC and decided they are recovered in this year. Watch out for more on this.

The HC presented a draft letter of comments on the Olympic Coast National Marine Sanctuary Draft Management Plan to the Council. The Draft Management Plan does not have any elements of fish management and the majority of the comments concerned the information interface between the Council and the Sanctuary. The Council adopted this letter with minor edits and will forward to the Sanctuary.

HC produced comments on the NOAA Aquaculture policy that may be included in

Council comments to NOAA and DoC. We did not like much about the Aquaculture policy. The Council initiative to move into Ecosystem Based Management is continuing with development of very high level concepts. Application to management appears years away.

Looking ahead, the April HC will have two hot items. The US Bureau of Reclamation will send a representative to discuss questions the Council posed concerning the CVPIA last year. The HC will also begin discussion on the ACOE National Standard for Levees that all but demands clear cutting every levee in the US so they can be visually inspected. The conflict with salmon EFH will be emphasis and HC will prepare EFH comments for the Council. Salmon EFH will be adopted for Council review; there does not appear to be anything that impacts management in this.

Safety at Sea-Are You Prepared

As we prepare to set sail for another Troll season off our Coast we should ask ourselves a few questions before we leave the dock so we and our loved ones whom we leave at home can be assured we are truly prepared for an emergency at sea. Here are a few you should be thinking about: Do you conduct regular safety drills on board your vessel and document them? Do you need a station bill for your vessel and/or do you know what a station bill is? In an emergency, could you manually deploy your life raft? By the way, manual deployment is the preferred method! Have you ever practiced donning your survival suit, and could you do so in less than one minute? Is everyone on board your vessel trained for an emergency including, for you bigger boats, fire training? Do you need a trained drill instructor aboard your vessel? Are you trained in C.P.R.? For some of us it is required. Do you possess all the necessary safety equipment because it is required or because you believe it can really save lives in an emergency? If you answered "NO" to any of these questions or are unsure, then my friend YOU are not prepared for an emergency at sea on board your vessel!

My dad has always told me that preparation is 90% of success, and to be honest, my preparation prior to this season was well short of adequate. After a routine boarding at sea by the Coast Guard last season and failing because of an out of date FCC station license, I was informed I

also needed to take an Emergency Drill Instructor Workshop course, and in doing so learned that I needed to get my act together if I intended to survive an emergency at sea. The course was only one day located at Fisherman's Terminal in Seattle and was well worth the \$125.00 it cost me as the information taught was invaluable. The course covered many aspects of emergencies experienced at sea, how to prepare for them, and how to conduct and document safety drills. On a related note the Coast Guard has established a much more simplified "Commercial Fishing Vessel Examination Checklist" system so each and every vessel owner can determine what is required for his vessel depending on origin of registration, length of vessel and distance from shore where fishing effort will be concentrated. With these new "checklist's", there is no more ambiguity as to what is required for your vessel. 

MANIPULATION

“Ex-ploi-ta-tion (n) 1. The use of something, esp. for profit. 2. The use or manipulation of another person for one’s own advantage.”

Each year, the Pacific Fishery Management Council (PFMC) receives from the National Marine Fisheries Service (NMFS) a “guidance letter” which summarizes the conservation needs for salmon listed under the Endangered Species Act (ESA). When Lower Columbia River Tule Chinook were first listed (1999), the harvest was restricted to 65% of the expected return. From 2002 to 2006, this exploitation rate was lowered to 49%. It was further reduced to 42% in 2007, 41% in 2008 and 38% in 2009 and 2010. This year, the NMFS mandated a 37% exploitation rate. I have been told that for this coming season, every seven tenths (0.7) of one percent of the 37% rate is equivalent to 10,000 salmon...

At the PFMC meeting in Vancouver last week, Dr. Robert Kope, chair of the Salmon Technical Team (an advisory body of the PFMC) was asked by the Council what the actual, after the season exploitation rates were for the past two years. It was like E.F. Hutton was speaking. And his answer was indeed jaw-dropping: 36.6% in 2009 and 34.5% in 2010. Pressed further for an explanation, Dr. Kope said that the fish just weren’t caught. Do you see the irony?

So the difference between the 38% restriction and the final outcomes is 1.4% in 2009 and 3.5% last year. How many fish does that amount to? How much taxable income did we NOT catch? Could your checkbook and the economies of our coastal communities have used that money?


Looking back at the definition above, I’m not wondering “what” is being exploited but “who” is being exploited... and “why.” Will it ever turn around?






